### ●Closed System Drug Transfer Device named "NEOSHIELD"



This product is a system for medical staff to handle cancer drugs safely in cancer chemotherapy. With the design and the materials that do not expose the internal drug flow path to the outside of the system, and the fulfilling range of the system, this product prevents exposure to cancer drugs at each step of the process, from preparation to administration and disposal of cancer drugs, which supports medical staff to realize safe and efficient operations.

### 【The judge’s comment】

When medical staff handles cancer drugs (preparation, administration and disposal), there is always the risk of exposure to cancer drugs due to splash of the drug solution at each step. This product was highly evaluated for the system with the excellent closed mechanism for preparation and administration, as well as the design realizing simple and efficient operation. We would like to express our deep respect for the ingenuity and effort of the people involved in the design of this product.
