Notice regarding Establishment of New Company in the Philippines and Factory Building at IZUMO plant for production capacity enhancement.

 \sim For global business expansion to meet growing global healthcare markets \sim

JMS Co., Ltd. (headquarters: Hiroshima, Japan; President: Hiroaki Okukubo; hereinafter: JMS) announces to establish a new company in Republic of the Philippines and a new factory building at IZUMO plant, the domestic mother plant for business expansion in Japan and overseas markets by enhancing production capacity and cost competitiveness.

1. Background and Purpose

Recently, there are growing demands for safer, more reliable, and high quality medical products, especially in emerging countries based on the improvement of medical infrastructure and national income driven by their strong economic growth. In Japan, the national healthcare expenditure is soaring likewise due to the growing demands driven by the aging society along with more advanced but expensive medical treatments. Given this situation, the government is trying to curb the growth of total healthcare expenditure to deal with the financial deficit and its healthcare budget. For this reason, it is increasingly important to provide the medical products which can support more cost-efficient medical services.

JMS Group has been providing medical products to patients and medical professionals in more than 80 countries from our production sites located in Japan and Asian countries. We have decided to establish a new plant in the Philippines and additional factory building at our mother plant located in IZUMO to meet these growing global demands for medical products as a source of our growth, and supply the products for more cost-effective medical service by enhancing our cost competitiveness. We will proceed with restructuring of production sites utilizing their strength and capability to the maximum extent from the viewpoint of group-wide optimal production for global business expansion.
